OH Line Patrol Recommendation for 2020- Mr. Mobley

Mr. Mobley made his recommendation for the OH Line Patrol Contract for 2020. We bid this when we first started the line patrol and McCall Thomas submitted the lowest bid; we have been renewing with them annually since then. In 2016, the amount was \$110,250; it was reduced to \$105,750 in 2017 and stayed at that amount in 2018 and 2019. McCall Thomas has done a great job and they have agreed to keep the cost the same in 2020. Upon motion by Mrs. Shuler, seconded by Mr. Chavis and unanimously passed; it was

UG Inspection and Testing Recommendation for 2020- Mr. Mobley
